IMPORTANT TERMS & CONDITIONS

(To be submitted on bidder's letter head duly signed and stamped by the authorized signatory)

- 1. Timely servicing/ rectification of defects during the warranty period:** After having been notified of the defects/ service requirement during the warranty period, bidder/ seller has to complete the required service/ rectification within 10 to 15 days' time limit. If the bidder/ seller fails to complete service/ rectification within the defined time limit, a penalty of 1% of the unit price of the product shall be charged as a penalty for each week of delay from the bidder/ seller. Bidder/ Seller can deposit the penalty to the buyer directly else the buyer shall have the right to recover all such penalty amount from the Performance Bank Guarantee (PBG). Cumulative Penalty cannot exceed more than 10% of the total contract value after which the Buyer shall have the right to get the service/ rectification done from alternate sources at the risk and cost of the bidder/ seller besides forfeiture of the PBG.
- 2. Warranty:** The warranty period of the supplied products shall be 05 (five) years from the date of final acceptance of goods or after completion of installation, commissioning & testing of the goods. Warranty Certificate must be submitted by the successful bidder at the time of delivery/ installation of the medical equipment. The bidder/ seller should guarantee the rectification of medical equipment in case of any break down during the warranty period. Bidder/ Seller should have well established installation, commissioning, training, troubleshooting and maintenance service group in Gujarat for attending the after sales service.
- 3. Service Centres:** Details of service centres in Gujarat to render services for equipment to be furnished to Bhagyoday Charitable Trust with complete address, contact numbers, email ids, etc. at the time of delivery. It is the responsibility of the bidder/ seller to ensure that the authorized service centres are available to cater to the areas where supplies are made within reasonable distance from where the service calls can be handled. Details of dedicated toll-free numbers for service call and online registration of service requests also to be provided to the buyer at the time of supplies.
- 4. Source of Supply:** It shall be the responsibility of bidder/ seller to provide documents regarding source of equipment such as copy of Proforma Invoice or any other documents to establish that the products supplied are manufactured by the OEM indicated and sourced from them.
- 5. Packing and Marking:** Medical equipment being very delicate and sensitive packing for the goods should be strong and durable enough to withstand transit including transshipment (if any), rough handling, open storage, etc. without any damage, deterioration, etc. The size, weights and volumes of the packing cases, remoteness of the final destination of the goods, availability or otherwise of transport and handling facilities at all points during transit up to final destination, quality of packing, the manner of marking within & outside the packages and provision of accompanying documentation shall take in to consideration the type of medical equipment being supplied. The accessories shall be suitably labelled and packed. Each of the package shall be marked on three sides with indelible paint of proper quality indicating contract number and date, brief description of goods including quantity, packing list reference number, country of origin of goods and any other relevant details.
- 6. Spare Parts:** Seller shall provide materials, information, etc. pertaining to the spare

parts manufactured and supplied by the OEM. It shall be ensured that the required spares are available for purchase at least for 05 (five) years from date of supplies. In case due to any reasons the production of the spare parts is discontinued, sufficient advance notice should be given to the buyer before such discontinuation to provide adequate time to purchase the required spare parts, etc. (if required). Further, OEM and their service centres/ dealers shall carry sufficient inventories to assure ex-stock supply of consumables and spares for the equipments so that the same are available. OEM or reseller shall always accord most favoured client status to the buyer and shall give the most competitive price for spares and consumables of its machines/ equipment supplied.

- 7 Installation, Training and Manuals:** Seller shall be responsible to carry out Installation & Commissioning, Supervision and Demonstration of the goods supplied. They shall provide required tools for assembly, minor civil works for the completion of the Installation and Training of buyer's representatives for operating and maintaining the equipment and supplying required number of operation & maintenance manual for the goods. In case the category parameters are specifying any requirements regarding the installations, training and manuals the same shall also be applicable.
- 8 Electrical safety checking:** Sellers are required to make sure that they furnish the list of equipment for carrying out routine and preventive maintenance to the buyer. They should make sure to periodically check the electrical safety aspects as per BIS safety standards or equivalent. In case they do not have required equipment for such testing should ensure that the equipment checked for electrical safety compliance through labs with facilities for such checking during every preventive maintenance call.
- 9 Software:** All software updates should be provided free of cost during the entire warranty period i.e., 05 (five) years.
- 10 Manufacturer Authorization:** Wherever authorized distributors/ service providers are submitting the bid, an Authorization Certificate with details of the Original Equipment Manufacturer (OEM)/ Original Service Provider such as Name of the contact person, designation, office address, official e-mail id and Phone No. are required to be furnished along with the Technical Bid (Part 1).

This is a two-part tender process. The two parts are as follows: -

PROJECT TIMELINES: -

Time is the essence of contract. The bidder shall complete the work as per scope of work within in a time bound manner as required/ stipulated by Bhagyoday Charitable Trust. In case of delay in services or meeting the timelines/ deadlines stipulated by Bhagyoday Charitable Trust, apart from imposing penalties as decided by Bhagyoday Charitable Trust, the Liquidated Damages shall be levied as mentioned below in the relevant clause.

DELIVERY PERIOD: 60 (Sixty) days from the date of award of work/ site-readiness.

PERFORMANCE SECURITY/ BANK GUARANTEE (PBG): -

1. The successful bidder shall furnish Performance Bank Guarantee (PBG)* to Bhagyoday Charitable Trust at the rate of 5% of the total contract value with a validity of warranty period + 2 months claim period, in the form of a Bank Guarantee from a scheduled commercial bank or a Bank Draft in favour of Bhagyoday Charitable Trust, payable at Himmat Nagar, Gujarat. The Successful Bidder has to submit the required PBG to the buyer within 10 (ten) days after award of work.
2. EMD of the successful bidder will be retained till PBG is submitted. No payment will be released without submission of the required PBG. Non-submission of the PBG may lead to termination of the contract and getting the work done at bidder's risk and cost including forfeiture of the EMD.
3. Bhagyoday Charitable Trust can deduct compensation from the Performance Bank Guarantee for failures on the bidder's part to complete its obligations under the contract.

PAYMENT TERMS: -

1. No advance payment shall be made.
2. **80% payment of the total contract value after successful delivery of the required medical equipment at the delivery location as mentioned in this document and submission of the Performance Bank Guarantee (PBG) to Bhagyoday Charitable Trust.**
3. **Remaining 20% payment after successful installation & commissioning of the delivered medical equipment which should be as per the satisfaction of Bhagyoday Charitable Trust.**

1. 
